Waiting List and Bond Payment

WAITLIST APPLICATION FEE

- \$50 per family
- Non-refundable

BOND PAYMENT

- A bond consisting of two weeks' full fees per child must be to secure a position at the Service.
- Refundable pending the following conditions are met.

CONDITIONS FOR BOND REFUND

Bond payment will be refunded to families when the child leaves the Service, and the following conditions are met:

- The required notice period is observed (10 business days' notice to cancel a placement, excluding the scheduled yearly Christmas and New Year closure of Little Saints).
- All accounts are paid in full, with no outstanding balance.
- If the family receives Child Care Subsidy (CCS), the CCS reconciliation period of 14 weeks from last attendance is observed. This ensures no CCS deduction is made from an account that requires payment from the family after they have left the Service.

When a family permanently increases their child's booked days, a bond equivalent to two weeks of the additional day fees is required to secure the new booking. This bond is applied to your account in the next invoice processing cycle.

NAPPIES

Families are required to provide a minimum of six (6) nappies per day for their child. Where sufficient nappies have not been provided, the Service will supply nappies from the centre's backup provisions to ensure the ongoing care, hygiene, and wellbeing of the child. A fee of \$1.00 per nappy (inclusive of GST) will apply for each nappy supplied by the Service and will be charged to the family account accordingly.

CANCELLATION/AMENDMENTS OF BOOKED DAYS

A two-weeks written notification is required for all cancellations and amendments of permanent If less than two weeks' notice is provided, the full day rate will apply.

We request a minimum of 48-hour notice for cancellations of booked casual days. Fees will apply if less than 48 hours' notice is provided.

Fee Subsidies Available

CHILD CARE SUBSIDY

Little Saints Early Learning Centre is an approved childcare service, which means families enrolled with us may be eligible for the Child Care Subsidy (CCS) to help reduce the cost of care.

KINDY FUNDING

Little Saints is an Approved Kindergarten Program Provider, which means we offer the Queensland Government's Free Kindy program. Free Kindy is designed to ensure eligible children receive 600 hours of fee-free kindergarten each calendar year.

Who is eligible?

- Children who turn 4 years old by 30 June in the year they attend kindergarten (generally the year before Prep).
- Children must be enrolled in the program for 15 hours a week, across 40 weeks (or a total of 600 hours for the year).
- Families can only claim Free Kindy for one program per child, per calendar year.
- Children not receiving the Child Care Subsidy (CCS) are still eligible for Free Kindy funding if enrolled in an approved kindergarten program at a long day care service.

Wrap around Kindy Care

Little Saints is a long day care service. Which means the difference between the daily fee and the Free Kindy hours is charged to families, with the Child Care Subsidy (CCS) available to help reduce costs for eligible families.
